RE: Complete Streets Training Session

On Wednesday the 29th of September I attended the Complete Streets Training Session at the Sarvis Center in Flint. This was presented by LSL Planning, Inc. and sponsored by the following:

- Safe & Active Genesee for Everyone (SAFE)
- Genesee County Health Department
- Michigan Dept. of Community Health
- The Disability Network

This program was coordinated by Lauren Holaly from the Crim Fitness Foundation. The lead speaker was Bradley Strader, AICP, PTP from LSL Planning Inc.

A portion of this presentation was intended to show the relevance of Complete Streets ideas and the importance of these concepts to our communities. I believe that most of the council members can already see the benefits of the Complete Streets program and the new life that these ideas can and will bring to the Downtown Area of Fenton.

In order to set in motion the Complete Streets initiatives it is recommended that a Complete Streets Resolution be adopted for the city. A sample resolution is included for your appraisal. As you can see, the Complete Streets Resolution takes into account many different types of transportation, both motorized and non-motorized. It also strives to construct safer and more pedestrian friendly streets and gathering areas for all citizens regardless of age or disability. The Resolution is an attempt to align all city departments, along with the public, to the betterment of the

downtown area which will ultimately improve the entire City of Fenton.

With the Resolution in place the focus can then be placed on implementing the plan and securing grant monies for construction.

I was surprised to learn that both the Genesee County Health Dept. and the Michigan Dept. of Community Health are strong supporters of the Complete Streets Policies. Both have inputs for the betterment of the general welfare of our community and I believe that they are able to secure some monies for these types of projects.

In closing I would like to suggest that the administration bring this before council for full discussion and possible inclusion to the Resolutions of the City.

Dear Clerk:

This letter is in reference to the recent action taken by the Legislature that amended Section 1111 and Section 1113 of the Michigan Liquor Control Code of 1998, being MCL 436.2111 and MCL 436.2113. These amendments allow for the sale of spirits, mixed spirit drink and beer and wine between the hours of 7:00 a.m. on Sunday and 2:00 a.m. on Monday.

MCL 436.2111 allows for the sale of beer and wine between the hours of 7:00 a.m. on Sunday and 2:00 a.m. on Monday unless the local legislative body has prohibited such sales.

MCL 436.2113 allows for the sale of spirit and mixed spirit drink between the hours of 7:00 a.m. on Sunday and 2:00 a.m. on Monday, unless the legislative body of a county or the local legislative body has prohibited such sales.

If your governmental unit or county chooses to prohibit the sale of spirits, mixed spirit drink and/or beer and wine between the hours of 7:00 a.m. on Sunday and 2:00 a.m. on Monday, please submit your resolution or ordinance prohibiting such sales to this office by 5:00 p.m. on December 15, 2010. If we do not receive a response from you by this deadline, we will assume that you currently have no resolution or ordinance that would prohibit the sale of alcoholic liquor between the hours of 7:00 a.m. on Sunday and 2:00 a.m. on Monday. You do retain the right in the future to prohibit Sunday Sales.

Unless we hear from you concerning this matter, it is our intent to begin issuing the early morning Sunday Sales Permits to our licensee's on December 16, 2010 in those governmental units that currently authorize Sunday Sales.

CITY OF FENTON RE: Creative Foam Tax Exemption Request

Creative Foam, located at 555 Fenway Drive, has submitted an application to our offices for an Exemption of New Personal Property(Public Act 328). This application is requesting a 100% exemption on new personal property to be purchased. The estimated tax revenue to the City would be \$8200.00 annually. The applicant is proposing to implement a \$1.5 million expansion to supply a renewable energy market. This plan includes adding 63 new employees with an average weekly salary of \$500.00 within the next 5 years.

Included for your review is the letter of request, application, the letter from MEDC granting a MEGA tax credit to Creative Foam as well as the application that was sent to MEDC. If the City of Fenton grants this request, it will be a 5 year exemption beginning in the year 2011.

As you will find from reviewing the attached documents, MEDC requires the local unit of government support in order for Creative Foam to take advantage of the MEGA tax credit. The MEDC granted the MEGA tax credit to Creative Foam on October 26, 2010.

The IFT Subcommittee met on Monday, November 29, 2010 to review the application. During their meeting, a recommendation was made that the City Council review and approve a five-year Act 328 exemption for Creative Foam to begin in 2011.

Fenton City Council Members,

Since being founded in 1969 Creative Foam has called Fenton home. Our original location was on the old Shiawassee Avenue. We have since grown to have to our corporate office, engineering center and two manufacturing operations all in Fenton. We have expanded to Indiana, Tennessee and Colorado in recent years, but have kept our main campus in Fenton. We presently have over 240 employees that have Fenton as their place of employment. We wish to stay here and grow our business along with helping the local economy. We would appreciate your support as we consider Fenton for our next major investment.

We plan on investing \$1.5 million in an expansion of our Fenway facility to supply the renewable energy market. We will produce core kits that are used in the production of wind turbine blades. In the next five years we plan on adding 63 direct employees. These wage jobs will pay an average wage of about \$14 to \$15 per hour. The MEDC estimates the increased economic activity created by this program has the potential to create an additional 81 indirect jobs. This is a total of 144 new jobs that will help stimulate the local economy.

The City of Fenton has been good to Creative Foam in the past and we have helped in building the local infrastructure. With your help Fenton and Creative Foam will continue to prosper for many years to come.

II. FACTUAL DATA

A. LEGAL DESCRIPTION

B. OWNERSHIP, OCCUPANCY AND HISTORY

The above legally described property appears to have been acquired from the prior owner by Creative Foam Corporation in August of 1996. The property reportedly was acquired as vacant land, and the existing improvements were constructed in 1996/early 1997. The property has continued to be held under the current ownership since the time of construction.

The property is presently owner occupied.

Dear Mr. Graham:

It has been a pleasure working with Creative Foam Corporation on your proposed project in the City of Fenton. This letter outlines the terms and requirements that must be met for the company to utilize the incentives offered in support of your proposed project.

Michigan Economic Growth Authority (MEGA) Tax Credit:

The proposed 100% High Technology MEGA tax credit is for 5 years, beginning fiscal year ending June 30, 2012, the credit can be pulled forward one year if appropriate. Based on the information provided in your final application, we estimate the value of this incentive to be \$362,386. The availability of this credit and the terms described in this letter are contingent upon approval of the MEGA Board.

The company must meet the following requirements to be eligible for the tax credit. Failure to meet the requirements may disqualify the company for the credit or result in a forfeit of credit for the tax year in which the requirements are not met. The requirements are as follows:

- The company must create a minimum of 5 qualified new jobs the first year of the credit and a minimum of 25 qualified new jobs by the fifth year of the credit over the established employment base of 366.
- The maximum number of qualified new jobs that the company can request credit for in any given year is 63.
- The company must pay an average weekly wage of \$500.
 - Wages are capped at the first \$250,000 for any one individual; and
 - Box 1 W-2 data is utilized as actual wages for purposes of the credit calculation and to compute the average weekly wage, which must be at least \$500.
- The company must complete the initial capital investment associated with the project.

• The company must pay an administrative fee upon submission of the first year's tax credit application. The estimated value of your administration fee is \$1,812.
