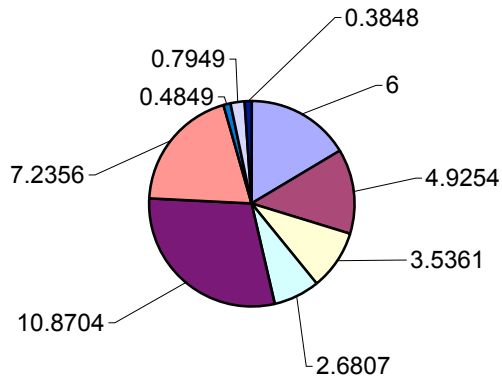


Non-Principal Residence



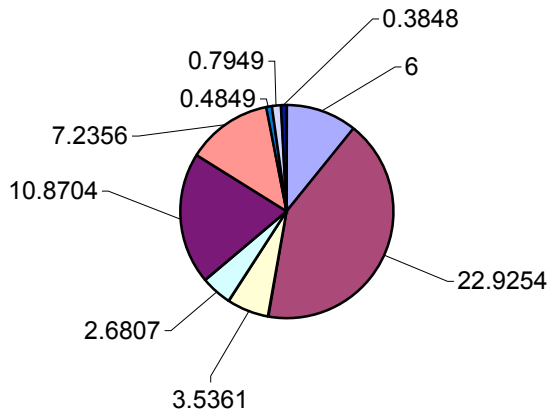
