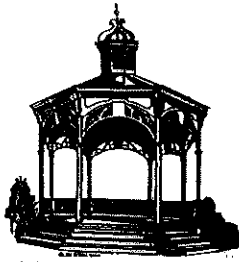
**RE:** Decorative Street Signs and Sidewalk  
Repair Program Discussion

Staff has completed an inventory of street intersection signs including street naming, Stop and Yield for all intersections in the city. Staff will present costs to replace the inventoried signs with standard signage and upgrading to decorative as discussed in previous workshops.

Staff has completed an address-by-address inventory of all sidewalks in the numbered street subdivision and will report cost for repair of existing and cost for missing sidewalk. The costs for sidewalk improvements for this subdivision may be helpful to implement a sidewalk repair program for the city.

RE: Silver Lake Park, Winter Closing

At the May 23, 2022 City Council meeting, staff presented a recommendation to close Silver Lake Park in the winter months to deter motorized vehicles from using the grounds of Silver Lake Park to access the frozen waters of Silver Lake. Council requested the item be tabled for staff and the Parks and Recreation Board to explore other options. Council desired SLP remain open for public use year around.

The Parks and Recreation Board discussed this topic at their June 14<sup>th</sup> meeting. The P&R Board reconsidered the original recommendation and suggest the park remain open in the winter months with signs posted during the winter at the park entrance and beach area that reads to the effect:

***NO MOTORIZED RECREATIONAL VEHICLES PERMITTED IN THE PARK  
ACCESS TO FROZEN WATERS OF SILVER LAKE WITH REC VEHICLES IS PROHIBITED***

Staff will prepare signs for posting in the winter months. Staff will monitor the park for recreational vehicle activity and report to Council if further action is recommended to protect the park grounds and frozen waters of Silver Lake from winter recreational vehicle activity.

As there is no change in the operating days/times at Silver Lake Park, no action is required by Council.
